April 7, 2022

OVERVIEW OF DISCUSSION & INFORMATION ITEMS

- **Superintendent Darren Mazutinec** reported to the Board on various meetings and happenings in the division, including the recent board planning session and hiring of a new principal for Spring Glen Elementary School. He is currently in the process of completing annual principal evaluations.
- **Secretary-Treasurer Peter Wright** provided the Board with an update surrounding Raymond's recently announced capital project and upcoming planning meetings.
- **Assistant Superintendent Rob Doig** presented information to the Board surrounding learning disruption grants, summer school, the new K-6 curriculum, dual credit courses, and Hapara.
- **Brad Sommerfeldt, Director of O&M**, provided the Board with a department report. The Board expressed appreciation to the Operations and Maintenance Department for their work and asked Mr. Sommerfeldt to pass along their gratitude to the school custodians.
- The Board welcomed **Cardston-Siksika MLA Joseph Schow** to the meeting and thanked him for his ongoing support, particularly during the COVID-19 pandemic. MLA Schow discussed Bill 15, the Education (Reforming Teacher Profession Discipline) Amendment Act, with the Board and explained the Bill was introduced in the Legislature on March 31, 2022.
